**Subject: Withheld of Written/Practical Test for the post of Junior Carpet Instructor in Handicraft Department, Leh and Other Mechanic/ Operator in Mechanical Department, Leh.**

Whereas LAHD-SSRB, Leh had advertised one post of Junior Carpet Instructor and 2 posts of Other Mechanic/ Operator vide Advertisement No. 01 OF 2019 Dated: 09-01-2019 and 02 OF 2019 Dated: 5-03-2019 respectively.

Whereas notification of tentative dates for Written/Practical Tests was issued vide No. DE&CCL/LAHD-SSRB/W.T./20/3523-49 dated: 03-12-2020 for the above advertised posts.

Whereas vide SRO No. 653 dated 20-10-2019 and SRO 918 dated:26-10-2019, Government of Jammu and Kashmir had allotted different posts to the Administration of UT Ladakh wherein many of the existing posts i.e. Other Mechanic/ Operator In Mechanical Department and the post of Junior Carpet Instructor in Handicraft Department including others posts other Departments were found missing.

Whereas the above advertised posts of Other Mechanic/ Operator and Junior Carpet Instructor were done before the issuance of SRO NO. 653 and SRO 918 by Government of Jammu and Kashmir.


Whereas after allocation of posts to UT Ladakh vide SRO No. 653 and SRO 918 by the Government of Jammu and Kashmir, some discrepancies have arisen vis-a-vis the earlier sanctioned posts in the district and the newly allocated posts.


Whereas communication between the Administration of UT Ladakh and Government of Jammu and Kashmir is still going on to settle the discrepancies and confusions regarding the earlier sanctioned posts and the newly allocated posts.

**Therefore, in view of above circumstances and till the time the matter of allocation/division of posts between the UT of Ladakh and UT of Jammu and Kashmir is properly settled, the recruitment process of the two posts of Other Mechanic/Operator and one post of Junior Carpet Instructor is hereby withheld with immediate effect.**

Further updates on the recruitment process of the said posts shall be given at the appropriate time.
